Little Miss & Mister Franklin County Fair 2025**

1. This is an OPEN PAGEANT. Contestants do NOT have to be residents of Franklin County. We are OPEN to all residents of Kentucky who have lived in the state at least 6 months.
2. Contestants must be 5, 6, or 7 years of age as of June 30, 2026 — they must be at least 5 years of age and cannot yet be 8 years of age on that date.
3. Enter and be judged as a couple.
4. All contestants must meet and abide by all rules and regulations of the Little Miss & Mister Kentucky County Fair Pageant as well as those set forth in this document.
5. Contestants will appear in a solid color top of choice, jean shorts (no holes) and shoes of choice. May accessorize with belts, bows of choice.
6. Judges' decisions are final. Judging will be based on appearance, poise, personality and on-stage interview. Judges will not be from Franklin County.
7. Appropriate prizes will be given to the winners. Runners-up will be chosen.
8. Contestants must not have competed at the professional level. Professionalism is defined as "any contestant who has performed or competed for monetary gain in anything other than amateur contests."
9. The Franklin County Fair Board and all of its agents and volunteers cannot be held responsible for accidents, injury, or loss of personal property relating to this event.
10. Harassment of fair and pageant officials/volunteers will not be tolerated. Parental interference before, during and after the pageant could be cause for participants to be dismissed. Entry fees will not be refunded.
11. Little Miss & Mister Franklin County Fair 2026 are expected 1) to represent Franklin County Fair at the Little Miss & Mister Kentucky County Fair Pageant at the Kentucky State Fair August 20 (*wardrobe must be approved by local fair prior to state competition*); 2) to ride on the Fair Board's float in the Holiday Parade; and 3) crown their successors at the 2027 pageant.
11. Completed entry form along with
 - (a) **\$30 non-refundable entry fee**,
 - (b) photocopies of birth certificates, and
 - (c) ONE 4x6 photo of the COUPLE for possible publication should be mailed to:

LATE Registrations will be accepted until Thursday, July 16 with a \$40 non-refundable late registration fee. Late submissions cannot be mailed.
12. Entry fee should be paid in the form of a Money Order made payable to the Franklin County Fair & Horse Show, in cash or via Venmo. Please find the QR Code for Venmo in the beginning of the Pageants section. If using Venmo for payment of fee, please email your entry form in PDF or Word doc format, the birth certificate and photos.
12. A rehearsal will not be held for contestants.
13. Each contestant and one parent will receive one pass for gate admission (*does not include carnival rides*) which must be picked up from the extension office at a time coordinated with co-chairs. Otherwise, everyone pays the \$15 gate fees.
14. Contestants should check in at the Hancock Pavilion one-half hour prior to the pageant.
15. Each couple shall decorate a container of their choice to solicit People's Choice votes at \$1 per vote. Venmo or Cash only will be accepted. Entries should be turned in during pageant check-in. The money will be counted and logged for the couple. The containers will be set up at the pageant so others can vote. They will be collected, counted and added to the earlier totals during intermission. If a couple chooses not to participate in the People's Choice Award and is the winner of the pageant, they will NOT be eligible to receive the proceeds from the People's Choice Competition.
